2021 Warranty Statement

SAFETY PRECAUTIONS AND RECOMMENDATIONS

- The device is plugged in a voltage source, which can be extremely dangerous. Because of the high current it can get very hot very quickly.
- Do not store inflammable liquids, paper or other flammable things near the device.
- Do not touch the device during balancing, it can get very hot. Make sure that children do not have access to the device.
- Repairs and technical modifications must be carried out by a qualified electro-technician.
- Do not expose the device to possible penetration of water or other liquids.

DISPOSAL OF ELECTRONIC EQUIPMENT

If you decide to dispose used device please follow local waste disposal laws, do not throw away in a regular waste bin.

PACKAGING

Keep the packaging materials (plastic bags, foil, etc.) out of reach of children, as they are potentially dangerous – possible suffocation. The packing box may be fully recycled, but please follow local waste disposal laws.

WARRANTY STATEMENT

The issuer of warranty certificate REC d.o.o. declares that the product REC BMS will function properly within the warranty, if used accordingly with its purpose and instructions for use. Upon your written request, if made within the warranty period and with receipt enclosed, we will remove all defects and deficiencies in the product not later than within 45 days from the date of application. The warranty period will be extended for the time of repair.

The warranty period starts on the date of the invoice.

WARRANTY CONDITIONS

The issuer of warranty certificate guarantees the proper functioning of the product, if used properly, will repair or replace the product at the headquarters of the manufacturer, and will pay for the costs of transporting the product from the buyer to the producer (according to the current rates of Post of Slovenia), but no other costs.

This warranty does not apply in the following cases:

- failure to comply with instructions for use
- wrong wiring and/or wrong installation of the device
- intrusion of unauthorized personnel into the device
- negligent behavior with the product
- damage caused by mechanical shock or fault of the buyer or third parties
- damage caused by the intrusion of fluids into the device
- if the enforcement of the guarantee is not accompanied by an original invoice as proof of the time of purchase.

The warranty also does not cover damage caused in transport after the handover, a failure due to improper installation or maintenance, mechanical failure, caused by the user and higher force damage.

To enforce the repair during the warranty period you need this warranty certificate and the original receipt.

Warranty period: 12 months

We provide spare parts three times longer than the warranty period.
